# CASA Dean's MMU (Monday Morning Update)

## A Tradition of Excellence; A Standard of Success

Monday, December 11, 2017

#### Dear Colleagues,

This is the last MMU in this calendar year. As 2017 draws to a close, I would like to take a moment to wish you and your family a wonderful holiday season and express my sincere appreciation for all of your contributions throughout this year.

SIUC is at an exciting time to envision its future. Under the leadership of new Chancellor, Dr. Carlo Montemagno, we are targeting two goals, among others, by 2025: (1) SIUC will have 18,300 students; and (2) SIUC will move up to an R1 institution. It requires significant changes, including academic programs and administrative structure, to meet these two ambitious goals. Currently I am reading Joseph E. Aoun's new book: *Robot-Proof: Higher Education in the Age of Artificial Intelligence*, and I'd like to share some of my thoughts on higher education innovations in general, and on the roadmap toward our two goals by 2025 in particular. Let us review two recent higher education related news events, which I refer to as two "hypothesis."

<u>Hypothesis One</u>: Within the next 15 years, nearly 15% of the global workforce may need to switch jobs, according to a new report released recently by the McKinsey Global Institute. By 2030, 75 million to 375 million workers will change occupation categories while another 400 to 800 million could be displaced by automation and will be required to find new jobs entirely. While new jobs will be created during that same period, the big question is if workers will have the necessary skills to transition into these new roles effectively. Hypothesis Two: There are over 4,000 colleges and universities in the United States. Harvard Business School professor Clayton Christensen says that half are bound for bankruptcy in the next few decades. The U.S. Department of Education and Moody's Investors Service project that in the coming years, closure rates of small colleges and universities will triple, and mergers will double. The tuition for American colleges increased nearly 400 percent in the last 30 years, while median household income growth was relatively flat. Student debt soared to more than \$1 trillion. College enrollment has declined for five consecutive years. Hypothesis One directs us to think about what changes we need, as a 21st century university, to better prepare the next generation of lifelong learners. Are our academic programs keeping pace with changes in the workforce? What new curriculum and new programs should we develop to make our students robot-

proof? Hypothesis One also gives us an opportunity to meet our enrollment goal of 18,300 students in 2025, noticing that 18,300 is just 0.0002 percent of the 800 million people who will need to switch jobs world-wide. But we need a significant change in our ways of operating. As Dr. Aoun well put it, "We will need to re-envision the curriculum, invest in experiential education, and put lifelong learning at the heart of what we do. AI can serve as an enabler, assisting students in their learning journey through innovations such as adaptive learning that facilitate knowledge acquisition so that teachers will have more time to devote to helping students integrate their learning."

Hypothesis Two provides a solid background for reorganizing of our academic programs and structure so that SIU meets its 18,300 enrollment goal as well as its research goal of R1 status in 2025. The U.S. News had an article several years ago listing 10 reasons to be a research university [https://tinyurl.com/y7qq94t2], and to many people, R1 is considered sort of the pinnacle of higher education. Most government money and grant support go to R1 institutions. Therefore, this research goal will enhance SIU graduate education and supplement state funding with more grant dollars.

#### CASA WINTER POTLUCK

We hope you'll be able to join us for the CASA Winter Potluck this Thursday, December. 14. We'll begin at 11 a.m. in the TEC Multipurpose Room, where the Dean's office will provide turkey and ham to go along with all the delicious side dishes faculty and staff will bring.

Upon arrival, you will receive ballots for best appetizer, best salad, best hot dish, and best dessert; after sampling all contenders, fill out the appropriate ballot with the corresponding number from the tag on your favorite dish. 


Our EESA option is growing every semester. EESA stands for Education Equivalency Service for Architects. The NAAB evaluates the education received by architects in other countries and provides a list of topics those students must fulfill to have a US-equivalent education for licensure. The NAAB does not officially endorse any school in particular, but when the students ask NCARB, the National Council of Architectural Registration Boards, they routinely refer them to SIU.

Finally, the online Integrated Path to Architectural Licensure (IPAL) program approved by NCARB this year, begins in the fall. When it comes to innovation in architectural education, our School of Architecture faculty lead the way for the whole world! Congratulations!

- Please join me in congratulating the School of Allied Health (SAH) for its transfer articulation agreement with College of Lake County, Grayslake, IL. The agreement has been signed by SIU administration and College of Lake County leaders. According to the agreement, all graduates of the College of Lake County with an Associates of Applied Science (A.A.S.) degree in Medical Imaging and meeting SIU Carbondale admission requirements will be considered for admission into SIU Carbondale's Bachelor of Science (B.S.) degree in Radiologic Sciences (RADS): Education & Management (online), Magnetic Resonance Imaging (MRI) & Computed Tomography (CT), or Radiation Therapy Technology options in the College of Applied Sciences and Arts based upon the Department's enrollment criteria and space availability. Additionally, upon completion of all degree requirements, SIU will certify our pilot students at 1000 flight hours, down from 1500 hours, enabling our pilots to attain their Restricted Airline Transport Rating (ATP) 500 Hours sooner. 
Design Evanston Awards. Specifically designed not to be self-serving for design professionals, the awards are presented to owners responsible for the design excellence of local projects. Congratulations!

## PURDUE ACQUIRED KAPLAN

Purdue University in Indiana seeks to expand its land grant mission by acquiring a largely online, adult-focused provider with national scope. The U.S. Department of Education and the Indiana Commission for Higher Education have approved plans for Purdue University to acquire Kaplan University and create the state's newest public institution, the NewU, which is exclusively online, expanding access to higher education for working adults and others for whom traditional campus study is not accessible or attainable. Kaplan's 32,000 students and 3,000 employees will transition to the new university.

#### **IBHE NEWS**


Higher education is the only major sector of the state budget that received less funding in Fiscal Year 2018 than it did in Fiscal Year 2002. Accounting for inflation and unfunded mandates added since Fiscal Year 2002, higher education operations Fiscal Year 2018 buying power is only 52.9 percent of what it was in Fiscal Year 2002 dollars. For public universities it is only 49.0 percent. On Tuesday, December 12, 2017, the Illinois Board of Higher Education (IBHE) will meet and approve the Fiscal Year 2019 Budget Recommendations for operations, grants, and capital improvements.

These recommendations request a modest increase of \$254.4 million to assure public higher education can maintain their current buying power as well as a small number of targeted increases. Even with the recommended increases, the total general fund request is still lower than the total funding provided to the higher education system for Fiscal Years 2015 and 2017.

Monetary Award Program (MAP), \$100 Million – MAP was the only program of the higher education budget that received additional funding for Fiscal Year 2018. However, by historic standards, MAP funding remains low, covering fewer students and less of their tuition and fee costs. The requested increase will help improve educational attainment by reducing accessibility gaps by socioeconomic status and improve college affordability, particularly for underrepresented groups. Increased MAP funds appropriated in a timely manner will help draw students back to Illinois college campuses.



#### HUMAN PILOT BEATS AI IN DRONE RACE

Any thing you can do, AI can do better. Eventually. On October 12, NASA tested its autonomous drones with a human pilot. The AI and the human started out with similar lap times, but the human pilot eventually won out and ended up with a faster average lap time than the AI. The conclusion is important: autonomous drones may eventually be used for surveillance, emergency response, or inventory in warehouses.
